

# **TECHNOLOGY UPDATE**

## **SOPPA Notification**

CCSD 46 takes the privacy and online safety of our students very seriously. We have always taken steps to guard closely the student data collected within our networks or by the online resources we use in our schools. Student data is protected through comprehensive privacy policies and security measures such as firewalls, secure servers, intrusion detection software, and other methods. The district adheres to the following applicable laws regarding student data and privacy:

- Student Online Personal Protection Act (SOPPA) which guarantees that student data is
  protected when collected by educational technology companies, and that data is used for
  beneficial purposes only. (<u>Annual Notice</u>)
- Children's Online Privacy Protection Act (COPPA) which restricts the collection of personal information from children under 13 by companies operating websites, games, mobile applications, and digital services that are directed to children or that collect personal information from individuals known to be children.
- Children's Internet Protection Act (CIPA) which ensures schools protect children from harmful online content while promoting access to the educational resources available on the internet.
- Family Educational Rights and Privacy Act (FERPA) which governs information in a student's education record, restricting access and use of student information.

CCSD 46 values your child's privacy and strives to ensure that parents are aware of what web-based tools and applications are being used for educational purposes. # **IMPORTANT CALENDAR INFO**



Due to the construction planned at all school buildings during the summer of 2026, the District is beginning the planning process to adjust the school year calendars for the 2025-2026 and 2026-2027 school years.

In order to incorporate an **extra two-week period** into the summer of 2026 for the purpose of completing construction projects, the District plans to **start the 2025-2026 school year one week earlier than usual and start the 2026-2027 school year one week later than usual.** 

We are working with our high school partners to ensure that our winter and spring breaks continue to align to make vacation planning easier for our district families. We will share specific start/end dates as soon as they have been determined.

## **ISBE SECURITY BREACH**

Like many other school districts in Illinois, CCSD 46 recently received notice from the Illinois State Board of Education that they experienced two separate "data security incidents." The first data security incident occurred when student information was unintentionally made public on ISBE's website in a report pertaining to the SUN Bucks/Summer EBT program. ISBE has let us know that the scope of the security incident was very limited. It was a release of general student information in a format that was not downloadable. It was accessed on the ISBE website eight times, which ISBE believes were mostly internal team members who were working on the program or issue. There is no known impact to students or families. A secondary breach occurred on the ISBE website as school administrators were able to view the PEBT application data of not only students from their District who were affected

by the primary data security incident, but in some cases the list of students from other schools affected by the initial incident. Again, there is no known impact to students or families.

State and federal law requires that a record of each disclosure of student identifiable information be maintained in a student's official education record. Therefore, ISBE has asked school districts to place letters in the student records of students whose data was disclosed. We will be placing paper copies of such a letter in student files. An electronic copy will also be provided in the Infinite Campus Parent Portal under the Documents section on Friday, September 13. If you want to know if your child's data was a part of this ISBE security breach, please check Infinite Campus on or after that date.

# **CONSOLIDATED ELECTION: APRIL 1, 2025**



Tuesday, August 20, 2024, is the first day to circulate nomination papers for those interested in running for the Board of Education in the 2025 Consolidated Election. The election will be held on April 1, 2025. Nominating petition forms and Statements of Candidacy are now available from the <a href="Lake County Clerk">Lake County Clerk</a>. Petitions may be circulated from August 20 - November 18, 2024. The filing period is November 12-18, 2024. All documents, including political maps, petition packets, and more are available on the <a href="Lake County website">Lake County website</a>.

The Illinois State Board of Elections has made available the <u>2025 Candidate's Guide</u> and the <u>2025 Election and Campaign Finance Calendar</u>. The Candidates Guide includes a candidate checklist, information on campaign contributions and disclosures, petition forms, and other information for candidates seeking locally elected positions.

The Illinois Association of School Boards (IAS) also has a number of resources available for school board candidates, including a <u>list of key dates</u>, <u>Qualifications and Characteristics of a School Board Member</u>, and a series of livestream seminars. **GENERAL MEETING: September 4, 2024** 

The CCSD 46 Board of Education held a general meeting on Wednesday, September 4, 2024, in the Falcon Room of Frederick School.

President Stephen Mack called the meeting to order at 6:00 pm. Following the Pledge of Allegiance and the approval of the agenda was the opportunity for public comment. No public comments were made.

Board reports were presented as well as the Superintendent report. Dr. Glickman shared that we had a smooth start to the school year and expressed gratitude to the Park Campus community for their understanding during Friday, August 30's unexpected Late Start due to a neighborhood power outage. Mr. Scott Gaunky, Interim Director of Operations and Maintenance, addressed the cooling issues with the north wing of Grayslake Middle School caused by a broken air compressor. He noted that portable air conditioners were brought in as a temporary solution until the replacement part was installed.

President Mack then requested a motion for the approval of the Consent Agenda, which includes Minutes from previous meetings, the Personnel Report, Exception Report, and Accounts Payable. The motion carried.
